Terms and Conditions of Registration and Participation Badminton Tournament Saarbrücken from 10/10 - 12/10/2025

1. General

Courage! Saar-Lor-Lux e. V. (hereinafter referred to as the "Organiser") is organising a badminton tournament from 10/10 - 12/10/2025 at Joachim Deckarm Halle, Halbergstraße 84, 66121 Saarbrücken and is offering an accompanying programme including a large breakfast buffet and a party (hereinafter referred to as the "Event").

2 Registration & Cancellation

- (1) Registration can only be made online via the Organiser's website and is binding. The Organiser reserves the right to reject registrations without giving reasons. The closing date for registration is 05/10/2025.
- (2) The following event packages can be booked:
 - Sports package: Includes participation in badminton doubles (men's, women's, mixed) on 11/10/2025, catering (water, fruits, sandwiches) at the hall; cost per person: 30 EUR.
 - Party "Karma-Sutra": cost per ticket 10 EUR.
 - Large breakfast buffet on 12/10/2025: Includes breakfast buffet at Leidinger's Lust, Mainzer Straße 10, 66111 Saarbrücken; cost per person: 23 EUR.
- (3) All persons who are at least 18 years old and who have accepted these conditions of participation are eligible to participate.
- (4) Cancellation free of charge by the participant is possible until 10/09/2025 at the latest. In case of a cancellation after 10/09/2025, the Organiser will be entitled to keep the participation fee. The cancellation must be made in text form (e-mail is sufficient) and sent to info@couragesaarlorlux.de.

3. Participation Fee & Terms of Payment

- (1) The participation fee depends on the booked event package in section 2 and is to be transferred by the participant to the specified account of the Organiser.
- (2) The participation fee must be paid into the specified account by 06/10/2025.
- (3) Costs for participation in the tournament including travel costs to and from the tournament as well as accommodation shall be borne by the participants themselves.

4. Rules of the Badminton Tournament

Only the badminton tournament rules published on the Organiser's website shall apply.

5. Cancellation or Changes to the Event

(1) The Organiser is entitled to make changes to the Event in terms of time and/or location, to cancel the event in whole or in part, completely or temporarily, or to partly close or cancel it, insofar as this should be necessary from the Organiser's point of view.

- (2) Participants will be notified of such changes as far as possible in advance by e-mail and/or via the website (www.couragesaarlorlux.de).
- (3) If legally necessary, participation in the tournament may be made dependent on the presentation of certain medical evidence.

6. Data Protection

- (1) Information on data protection can be found in the data protection information on the Organiser's website (see here: https://www.couragesaarlorlux.de/index.php/datenschutz).
- (2) Participants declare that they agree that pictures may be taken of them before, during and after the Event and that these may be published exclusively on the channels of the Oraniser (website and Instagram) and other media of third parties (such as the Badminton Association of Saarland SBV (*Saarländischer Badmintoverband*)) within the scope of reporting about the Courage! Open. If participants do not agree to this, they must inform the Organiser in advance or during or after the event.

7. Liability

- (1) The Organiser excludes liability for damages of any kind, in particular for injuries to life, body or health for itself and vicarious agents, which arise for participants, with the exception of grossly negligent or intentional injuries. Furthermore, the Organiser does not accept liability for damage to property, theft or comparable cases of damage.
- (2) The Event will be conducted by the Organiser with the greatest possible diligence. Nevertheless, accidents are not completely avoidable. Participants therefore acknowledge that the Organiser has not taken out any insurance for the participants of Courage! Open. The conclusion of insurance policies (including accident and property insurance) is the sole responsibility of the participants. Cases of damage that are covered by the Organiser's general insurance shall be exempt from this.

8. Miscellaneous

- (1) The Organiser reserves the right to adapt these terms and conditions of participation if this should be necessary at its own discretion.
- (2) Should a participant behave grossly against the rules or violate these terms and conditions of registration and participation in any other way, the Organiser has the right to exclude this participant from the further course of the tournament with immediate effect.
- (3) Legal recourse is excluded.
- (4) In case of any conflicts between the different language versions of these Terms of Participation, the German version prevails.
